Are there services covered before you meet your deductible?	Yes. <u>Preventive care</u> , Pediatric Dental and Pediatric Vision are covered before you meet your deductible.	This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount. But a <u>copayment</u> or <u>coinsurance</u> may apply. Does this plan provide Minimum Essential Coverage? Yes.
